Overall Purpose of Job

To Provide and coordinate exceptional patient care in Skin and Wound Management for

UPMC(University of Pittsburgh Medical Center)Beacon Hospital, in an environment

where quality, respect, caring, and compassion are at the centre of all that we do.

Key Responsibilities and Deliverables

- The Skin & Wound Care Coordinator nurse is accountable for the management and coordination of wound care/tissue viability and nursing services within the Wound Care clinic an Inpatient Services.
- Advance Certificate from a recognized program for Wound Care Management.
- The appointee is accountable to the ADON of Surgical Services and the Director of Nursing. He/ She will coordinate and provide effective team participation and leadership within a multidisciplinary team.
- Assists with the provision of expert clinical advice and training to the primary health care team. Liaise with other professionals and team members involved in the management of wound care in acute and chronic wounds demonstrating the ability to assess and manage patients in collaboration with the consultant physicians.
- He/ She will advance current nursing practice in accordance with ABA guidelines, using on-going education in-services and training for hospital staff members, patients and their families.
- Develops and implements a wound care program to include patient care protocols, documentation tools, wound care formulary and WOCN referral criteria..
- Competent to assess patients using Doppler Ultrasound and applying safe compression therapies in a range of clinical diagnosis.

- Develop, in collaboration with UPMC Quality department and matrix a Skin Integrity Program for Inpatients employing JCI standards.
- Monitors fiscal budget to control operational and capital expenditures while monitoring and adjusting resources to improve productivity and outcomes.
- Identifies appropriate internal quality controls for department; providing mechanisms to monitor and enforce best practices, trends and report data related to Skin integrity and wound care outcomes, following Infection control standards and practices.
- Performs other related duties as required.

Working Environment:

- Work environment is located in a comfortable indoor area.
- Conditions such as noise, odour, cramped workspace and/or fumes could sometimes cause discomfort.
- Moderate to extreme physical effort may be required such as walking, standing and lifting materials, equipment, objects, and/or patients.
- Occasional lifting may be heavy and awkward, over 50 lbs.
- Vision, hearing, talking, and sense of touch abilities must be adequate enough to enable one to quickly and accurately perform tasks such as: reading small print, reading from monitoring equipment, defining details, sending and receiving clear and accurate verbal communication.
- Frequent periods of concentrated or focused attention will be needed to interpret visual, auditory, and sensory inputs.
- Shift work may be required.
- Alertness and careful attention to detail will be required to avoid injury.
- May be exposed to such occupational hazards as communicable diseases, radiation, chemotherapeutic agents, and disoriented or combative patients.

May be required to be on standby and work extended shifts in situations deemed necessary by a designated Executive Director and/or Nursing Director.

Communication and Accountability

- Utilizes effective time management skills.
- Participates in unit/department problem solving and improvement of systems.
- Adheres to Standard Precautions as appropriate
 - The use of protective barriers as appropriate;
 - Handling and disposing of infectious waste appropriately.
- Hand hygiene as appropriate

Inter-relationships

- Maintains good working relationships with other departments and with physicians, Patients, families and outside agencies.
- Communicates during the shift with the Nurse Supervisor and/or Manager and/or Director of Nursing
- Demonstrates the ability to delegate tasks and responsibilities
- Participates in ongoing consultation and collaboration with physicians and other care providers to maximize patient outcomes and unit specific goals.
- Participates in unit-based and interdepartmental QI activities.
- Demonstrates willingness to assist co-workers whenever needed providing resources and education to advance the practice of Skin Integrity and Wound care within the hospital and community.
- Participates at a committee level for Quality programs

Other Duties and Responsibilities

- Maintains professional appearance and dress code.
- Complies with guidelines for absence or tardiness
- Attends unit staff meetings when possible, reads email and other postings.
- Attends all required in-services.
