### Overall Purpose of Job

The purpose of this role is to assist the pharmacist in providing excellent pharmaceutical care to the patients of Beacon Hospital. The pharmacist will make sure the pharmacy runs efficiently, while providing exceptional patient care in an environment where quality, respect, caring and compassion are at the centre of all we do.

### Key Responsibilities and Deliverables

- The supply of medicines and related items as may be required.
- The purchase, storage and supply of all items consistent with quality and value for money.
- The provision of clinical services, including the provision of advice to medical and nursing staff.
- Ensure the timely collation and input of all data concerning drug usage in the hospital, in line with departmental policy.
- The performance of all duties and responsibilities in line with all Pharmacy Department procedures and protocols, as well as hospital wide procedures.
- Participate in policy formation and the development of pharmaceutical services.
- Participate in continuing education and research activities consistent with the post.
- Ensure the cost effective use of medicines.
- Ensure best practice and compliance with agreed clinical guidelines.
- Ensure that the medication use process is measured, analysed and optimised by undertaking regular clinical audits.
- Ensure that all departmental and hospital wide Health and Safety protocols and procedures are adhered to and all areas of non-compliance are promptly addressed.
- To provide cover to the Dispensary, Clinical, Medicines Information and Aseptic services as instructed from time to time by the Pharmacy Manager.
- Must have working or technical knowledge of new technologies including automation.
