## **Overall Purpose of Job**

The Department of Cardio Thoracic Surgery at UPMC Beacon Hospital is a consultant delivered service. The team consists of Cardio Thoracic Surgical Consultants who work in collaboration with the Cardio Thoracic Registrar in patient care and in formulating management plans for patients.

#### **Key Responsibilities and Deliverables**

- To act under the supervision of the Cardio Thoracic Consultant in the provision of a Cardio Thoracic Surgical service and to support the Cardio Thoracic Consultant in their duties.
- To admit patients
- To attend daily ward rounds with the Cardio Thoracic team.
- Take hand over of patients from previous shift Registrar, so that continuity of care is ensured and immediate decisions are made and orders written.
- To review patients on a regular basis in accordance with the plan of care made at the beginning of the shift and inform the consultant of any issues or problems.
- Document review findings in clinical notes in a timely and legible manner.
- To cover Operating Room duties as assigned.
- To respond to any adverse occurrences e.g. injuries, falls, sudden illnesses etc, suffered by patients, visitors or staff.
