The data analyst will be specifically responsible for the data integrity of both the transactional & static data within PeopleSoft, to ensure the maximum use of the internal systems and provide the analysis and reporting required in satisfying the business needs of the wider financial team and its customers

Key Responsibilities and Deliverables

- Carries out data analysis to support the overall purpose of the department.
- Ensure excellent data integrity of all SCM data in line with UPMC protocols and the requirements of UPMC Beacon Hospital.
- Ensure that all transactional queries are rectified and cleared in an efficient and timely manner.
- Set up and maintain item data and pricing data as required.
- Generate, Approve and Dispatch purchase orders for issue in a timely fashion.
- Ensure that any purchase orders generated are correctly identified.
- Ensure that special requests, blanket orders and capital requests and service requests are used appropriately and coded correctly.

- Be PeopleSoft and e-Pro super user; maximising the use of the system, providing advice to users and training, analysis & reports as necessary.
- Resolve invoice match exceptions in a timely fashion.
- Work with Accounts Payable and wider finance team to manage supplier accounts and provide accuracy of data to financial reporting.
- Liaise with Revenue Cycle to reduce AR days by providing accurate and timely data for insurance companies.
- Provide support for internal costing programmes.
- Follow up on back-orders to ensure that all orders are delivered complete and in the shortest possible lead time.
- Be a SOX tester for SCM.
- Produce regular reports for use within SCM and the hospital management team as required.
- Performs any and all other duties as assigned by Supply Chain Manager taking on any extra projects as required.
