### Overall Purpose of Job

UPMC Beacon Hospital will provide exceptional patient care in an environment where quality, respect, caring and compassion are at the centre of all we do.

To provide quality care to all patients at all times. The fundamental philosophy guiding this position is to promote and preserve the UPMC Beacon Hospital Mission and Values while adhering to the Hospital's health and safety regulations.

### Key Responsibilities and Deliverables

- To follow the Hospital admissions process by documenting History and Physical examination.
- To assess/review and document findings for patients as requested by the attending Consultant and/or Nursing Staff.
- To provide Clinical Cover for procedures undertaken in departments e.g. Cardiology Stress Test and Radiology IVP Injections.
- To prescribe medications for patients as required i.e.
  - as directed by Consultant
  - all patients admitted are seen by a SHO and medications prescribed
- To respond to emergency situations.
- Participates in ward rounds.
- Completes the discharge process with a discharge letter.
- To respond to any Adverse Occurrences e.g. injuries, falls, sudden illnesses etc, suffered by patients, visitors or staff.
- To contribute to quality improvement and risk management initiatives wherever possible.
- To protect and enhance the reputation of the Beacon Hospital at all times.
- To adhere to hospital policies and procedures e.g. blood guidelines, infection control.

## UPMC Beacon Hospital

- To implement quality standards ensuring that a quality service is provided at all times.
- To comply with Health and Safety Regulations, ensuring safe working practices and a safe working environment.
- To undertake any other duties that may reasonably be required.
- Liaises with nursing supervisors, nurse managers and nurses in charge when on duty.
